Ichigaya Disaster Prevention Framework

The UN world conference of Disaster Risk Reduction,

Recalling the Sendai Framework for Disaster Risk Reduction,

Recognizing that the United Nations Office for Disaster Risk Reduction (UNDRR) contributes to international disaster reduction,

Recalling the Conference of Parties (COP),

Affirming that Official Development Assistance (ODA) is playing an important role when providing assistance,

Recognizing that not only women but every single person should be respected in case of disasters,

Taking into consideration the economic disadvantages of underdeveloped nations in terms of bettering their disaster prevention and risk reduction activities aligned with the issue of climate change to build resilience in terms of natural disasters.

Noting with concern the disparity in female and male representation in natural disaster response,

Alarmed by the numbers of disaster- vulnerable victims such as women, children, disabled and elderly people in cases of natural disasters.

Emphasizing that to not leave behind women and other vulnerable populations regarding natural disasters is a common goal amongst the world,

Recognizing the importance of s system to ensure an equal distribution of aid throughout the world,

Recognizing that certain countries have more information and experience regarding the disaster management and prevention of natural disasters compared to other nations,

Recognizing the necessity of international cooperation to promote the development of disaster prevention technology,

Approving the benefits of a multi-hazard early warning system (MHEWS) in the prevention aspect of disaster risk management, which is a target of the Sendai Disaster Prevention Framework,

Noting its satisfaction for the Green Climate Fund and the benefits it serves for its response to climate change issues,

Recognizing that artifacts such as unexploded ordinances, buildings, power plants, etc. may pose a danger to the public due to the effect of disasters,

Recognizing that International Day for Disaster Risk Reduction should be utilized in terms of Disaster Risk Reduction and Resilience Building,

Recalling Intergovernmental Panel on Climate Change (IPCC), Asian Disaster Reduction Centre (ADRC), United Nations International Children's Emergency Fund (UNICEF), Organization for Economic Cooperation and Development (OECD), United Nations Office for Disaster Risk Reduction (UNDRR),

Convinced that ESG, especially an environmental perspective is an important factor to achieve a sustainable world for disaster prevention,

Noting with regret the current lack of a smooth response in case of disasters,

Recognizing that the Sendai Framework for Disaster Risk Reduction 2015-2030 includes instructions that the world should unite to carry out,

Regretting that there are many situations in which vulnerable people's privacy is violated, especially in the event of a disaster,

Reaffirming the importance of smooth response and action when disasters occur,

Recognizing that there are many people, especially vulnerable to disasters, whose daily needs are not met, despite the fact that different people have different necessities,

Believing that it is important to achieve inclusive measures against disasters,

Desiring to prioritize vulnerable people including women as inclusive measures against disasters,

Emphasizing the need to ensure transparency in the channels and uses of financial support on a one-to-one basis,

Believing that the issues of disasters caused by climate change must be urgently addressed internationally,

Emphasizing the importance of better facilitating disaster assistance and cooperation to developing countries that are suffering from climate change,

Recognizing the need to clarify the definition of developing countries receiving assistance for disasters,

Emphasizing the importance of sharing situations and expectations of disasters internationally,

Recognizing the situation where emergency alert system is getting complicated within each nation,

Emphasizing the necessity of every single person recognizing emergency alert in case of disasters,

Deploring that financial assistance toward developing countries in order to achieve the Sendai Framework for Disaster Risk Reduction 2015-2030 is insufficient,

Recognizing that financial assistance not only from each nation, but also from private sectors is important,

Recognizing the importance of achieving SDGs,

Recognizing the difficulty of carrying out disaster prevention not only in developing countries,

Noting with regret that the use of financial support for recent natural disasters lacks transparency,

- 1. *Requests* member states in each region to establish a disaster prevention cooperation system for their region, modeled on the ADRC, in areas with the lowest disaster risk in each region and to do the following:
 - a. Fostering and education of human resources including evacuation drills;
 - b. Establishment of an International standard on evacuation facilities;
 - Creation and collection of a detailed database of the natural disaster to ensure facilitation in terms of disaster management post the disasters;
 - d. Holding of international meetings regarding the issue of natural disasters and risk management;
 - e. Attendance of international meetings regarding the issue of natural disasters and risk management;
 - f. Establishment of a system to ensure opinions of disaster victims are heard through surveys on what kinds of care individuals are in need of;
 - g. Submission of results of measures taken by each country;
- 2. *Requests* the UNDRR and *encourages* member states in each region to fund the creation of the disaster prevention cooperation system in their region mentioned above;
- 3. *Requests* member states the following in terms of achieving an inclusive society for disaster vulnerable people including women in the involvement in disaster risk prevention of natural disasters:
 - a. Establishment of sanitary and hygienic evacuation centers with well-equipped sanitary products for female hygiene,
 - b. Establishment of evacuation centers with privacy for female and other disaster vulnerable victims,

- c. Dissemination of knowledge on disaster to the public regarding situations of disaster vulnerable people in evacuation centers,
- d. Holding of symposiums under the UNDRR to raise awareness regarding gender issues and other discrimination against minorities,
- e. Enhancement of education for women, children and other disaster vulnerable people upon disasters and their risks,
- f. Mental support of women and other disaster vulnerable people during disasters,
- g. Spreading of inclusive designs,
- h. Implementation of a system that ensures quick and efficient evacuation of disabled people in times of disasters;
- 4. *Encourages* international organizations such as UNICEF to fund to better disaster risk management education amongst women and children:
 - a. Financial support,
 - b. Medical supplies,
 - c. Human resource assistance,
 - d. Technical assistance;
- 5. *Encourages* nations that have the ability to financially or technologically support other countries with the following goals:
 - a. Economic recovery,
 - b. Reduction of natural disasters,
 - c. Construction of disaster resistant architecture;
- 6. Encourages member states the following policies in order to tackle issues regarding climate change:
 - a. Further collaboration with the UNHCR to reduce climate refugees,
 - b. Promotion of the establishment of a framework to accept climate refugees;
- 7. Requests member states to the share information across nations for the following:
 - a. Creation of hazard maps updated every two years,
 - b. Infrastructure to withstand disasters,
 - c. Disaster manual,
 - d. Countermeasures of landslides,
 - e. Information regarding landmine removal;
- 8. *Requests* member states to annually submit a report containing the following information to the UNDRR to report details of natural disasters that the country has suffered:
 - a. Basic information on the disaster,
 - b. Response the nation has taken,
 - c. Self-feedback on the response the nation has taken;
- 9. Requests member states to release the following information when a disaster occurs in their nation:
 - a. Information on the disaster that has occurred,
 - b. Necessary type and amount of aid that the nation requires;
- 10. *Requests* nations requiring aid to submit a document to UNDRR regarding the usage of aid provided for disaster management to ensure transparency in the aid transaction;
- 11. Requests the UNDRR to collect the following information regarding disaster prevention:

- a. Support that the nation is looking for,
- b. Support that member nations can provide,
- c. Amount of resources that can be devoted to the aids;
- 12. *Urges* the UNHCR to work to protect the human rights of evacuated people from persecution in their places of evacuation;
- 13. Requests Member States to carry out the following, in order to strengthen the rapid response when disasters occur:
 - a. Establishment of government agencies specializing in the following activities related to disasters:
 - i. Management of shelters,
 - ii. Reconstruction of areas affected by disasters,
 - b. Introducing a system of disaster volunteers, if possible:
- 14. *Encourages* Member States, if possible, to simplify disaster prevention system such as emergency alert, government agencies related to disasters within their countries;
- 15. Requests Member States to provide aid in alignment to the list of nations which receive the ODA;
- 16. Requests Member States to place a priority on the following nations:
 - a. The list of nations receiving ODA,
 - b. The nations where the impacts of natural disasters are more significant than other nations assessed by UNDRR;
- 17. Requests Member States to do the following, in order to implement smooth evacuation in case of disasters:
 - a. Providing multilingual information about disasters,
 - b. Enactment of international guidelines,
 - c. Making maps in each region to find out houses of people who have difficulties in evacuating in case of disasters;
- 18. *Requests* Member States on the development of guidelines with the establishment of a committee composed of experts;
- 19. Requests Member States to share disaster forecasts internationally as soon as disasters strike;
- 20. *Requests* Member States to establish international disaster insurance system toward nations which experienced terrible disasters,
- 21. *Encourages* nations which can afford to provide assistance to involve private companies and NGOs and pay actively for the insurance system referred to in Article 20;
- 22. *Requests* nations which can afford to provide assistance to give financial and technical support with the following goals to nations in need:
 - a. Construct infrastructure,
 - b. Economic recovery,
 - c. Reducing natural disasters;
- 23. *Encourages* the promotion of environmentally friendly infrastructure such as buildings that has greenery area in order to reduce natural disaster;
- 24. Encourages Member States to financially support corporations addressing ESG;
- 25. *Encourages* Member States to make use of International Day for Disaster Risk Reduction and to do the following in order to raise awareness of disasters:
 - a. Disaster drills.
 - b. Sharing and use of provided information from UN about disasters.
